Chair Cornell recognized County Attorney Michele Lieberman who stated that she had requested that staff inform Gainesville Police and the Alachua County Sheriff's Office. She further stated that demonstrators have been told to stay on the sidewalk and not block access to the County Administration Building during business hours.
