Approval of Agenda

Commissioner Cornell stated that having the history of how the service times were selected and if it is still relevant would be very helpful for this discussion.


**Commissioner Cornell moved** to authorize a Chair letter to the City of Gainesville to determine if there is any interest in beginning discussions regarding a possible Countywide Fire Rescue model under a dependent or independent authority. The motion carried 5-0.

By consensus, the Board directed staff to provide data on how things would change in moving from 6 minutes to 8 minutes response times and added to the list of items the Board wishes to set aside to for discussion.

#### **Potential Annexations**

Deputy Fire Chief Harold Theus and City of Gainesville Commissioner Hayes-Santos presented the above item.

Commissioner Hayes-Santos advised the County that the City is undertaking a census to determine if portions of the County are interested in the annexation into the City of Gainesville. The yellow areas on the map below delineate the areas the City is interested in annexing. He stated that it will be a yearlong process.



4. <u>Update on Property Assessed Clean Energy finance (PACE) Special Assessments</u> **Fiscal Consideration:** Staff currently only monitors PACE programs. Any administrative oversight or prepost assessment review will require additional resources in addition to amendments to existing interlocal agreements. **Recommended Action:** Hear presentation.

Strategic Initiatives Manager Sean McLendon presented the above item.

Communications Coordinator Mark Sexton, Deputy County Manager Harriot, Commissioner Byerly, Commissioner Hutchinson, Commissioner Cornell, Commissioner Chestnut, Chair Pinkoson, Commissioner Byerly, Tax Collector John Powers, Richard Bell, Esq., Robert Griscti, Esq., Chair Pinkoson, Ygrene Director of Government Affairs, and Commissioner Chestnut presented comments.

Commissioner Cornell requested that Ygrene provide to the Board a written response as to how the three none issues are resolved.

Commissioner Hutchinson, Renovate America Florida Director of Market Development and Externa Affairs Mike Antheil, Commissioner Byerly, Deputy County Manager Harriot Aron Davie, and Communications Coordinator Mark Sexton presented comments.

# **Commissioner Cornell moved** the following:

- 1. That staff meet with any applicable citizens that have had complaints as well as the Tax Collector's Office and ask each of the related PACE providers to provide a written response as to how those issues have been resolved.
- 2. Direct staff to brief the Board within 30 days as to the findings as well any proposed suggestions for improving consumer protections.
- 3. Request a written response from each of the PACE providers as to whether or not the support the current proposed consumer protection legislation as well as staff's analysis of the legislation.
- 4. Staff to classify the types problems and repairs and the Board can discuss the issues and possible scope of services based on the responses.

Commissioner Byerly and Commissioner Hutchinson presented comments.

2. <u>Confederate Soldier Statue Replacement Discussion</u>

**Commissioner Hutchinson moved** to authorize the Public Defender Office authorization to precede with their art in public places projects.

**Commissioner Byerly moved** to refer to the County Manager for recommendations on the following:
